The Challenge

Thorntons' relocation provided an opportunity to upgrade their existing technology, which had reached the end of its lifecycle. Up against several other suppliers in the tender process, Concept won the contract to replace all the basic copiers and printers with a sophisticated Document Distribution Solution built around today's more powerful, Canon multifunctional printers (MFPs). The new MFPs would offer Thorntons more flexibility because of their additional scanning and network printing capabilities, as well as cost savings. To develop the solution, Concept supplied 16 MFPs, along with the latest electronic Document Distribution software eCopy and its own training and sales support. Concept also supplied the latest UniFLOW solution to provide secure release printing and copying for complete security and peace of mind.



The Solution

The Benefits

Once the move was complete, Concept's Professional Services came on site to help Thorntons' employees learn how to use the new technology, easing the cultural change associated with introducing centralised printing, copying and scanning. It was particularly important that Concept made training available to all staff, including fee earners, as they often work late on lengthy, critical documentation, and hence need to know how to operate the technology without disruption.

A key change at Thorntons since its relocation has been how documents are distributed internally, as well as to clients and third parties. Facilitated by the additional functionality of the Canon MFPs - specifically its eCopy capability - there has been a growth in scanning volumes as employees increasingly look to create digital PDF versions of hard copy legal documents.

Once in a PDF format, eCopy allows easy transfer of the document from the MFP to their desktop for fast and secure saving into the firm's document management structure or for distribution by email.

To facilitate document accounting at the firm, Thorntons have linked uniFLOW to each MFP. uniFLOW is essentially a connector that asks users to input a network log-on and password, enabling the company to conduct an audit trail for every copy, print, scan and eCopy task that is carried out.

The MFPs have proven so successful that the firm has also introduced a further 3 devices into their remote offices and are hoping to replace all of its legacy printers and copiers with Canon MFPs in the future. Looking ahead, Thorntons is preparing to integrate eCopy with its document management system, once installed, to further streamline business processes.

Concept's high quality office technology solution is, today, one of numerous important factors helping Thorntons achieve its goal of providing an efficient and excellent legal service to its clients.
